

Council asks federal government for "some provisions for the defense of Vancouver" – May 28, 1888

The Health Inspector authorized to tear down the old building on the Hospital Lots and that the chain gang be utilized for that purpose. Carried. Alderman Bell-Irving resigns. Communication to H.P. Caron, Minister of Defense in Ottawa asking him to take some provisions for the defense of Vancouver before the departure of the Royal Engineers by having the necessary surveys and plans of fortifications made by them before leaving the Pacific Coast.

Vancouver May 28th 1888

The Council met on Monday May 28th 1888 at 7:30 P. M.

Present His Worship Mayor Oppenheimer, Aldermen Alexander, Brighthouse, Clark, Couth, Humphries, Lefevre and Oppenheimer.

The Minutes of last meeting were read and adopted.

Communications

From John Robson, Provincial Secretary informing Council that it was not the intention of the Government to take any action in regard to having the Province represented at the Industrial Exhibition at Toronto. Filed.

From John Robson, informing Council that it was the intention of the Government to keep faith with all concerned in the matter of contributing towards the establishment of facile communication between Vancouver and Lulu and Sea Islands. Filed.

From H. Abbott informing Council that he was starting out to explore the road from False Creek to the North Arm preparatory to building same. Filed.

From A. H. B. MacGowan, Secretary to the Board of Trade, submitting a resolution re the Selection of Dead Man's Island as a Site for a Powder Magazine. Filed.

That the following resolution be addressed to the Hon Sir A. P. Caron, Minister of Militia and Defense. Be it resolved that the Mayor and Aldermen of the City of Vancouver the Canadian Pacific Railway line connecting as it does the Atlantic and Pacific Oceans, is not only an important factor in developing the natural and commercial resources of the Dominion of Canada, affording, as it does in connection with its lines of Steamships on both oceans the shortest route between the Mother Country and her possessions in the East; entirely constructed in Territory over which the British Flag floats, is also of Imperial importance not alone in a Commercial sense but also as a Military route from East to West in case of necessity.

That it is all important on these grounds that such steps should be taken for its protection as would render it reasonably secure from hostile interference in case of War.

That at its Western Terminus Vancouver the Entrepôt on the Pacific Ocean for the Eastern Trade with a population of eight thousand persons, has sprung up having extensive lines of Docks and Wharves at which British Steamships from all parts of the world

are continually arriving, with large warehouses, manufacturing, establishments, industries erected in course of construction and protected which will soon make it the most important city in British Territory in this Province, second only to San Francisco on the whole Pacific Coast.

That this Council has learned that a Corps of Royal Engineers have been for some time engaged in planning fortifications at Esquimalt and that same will soon be completed and said Engineers will then depart from this Province.

That this Council earnestly press upon the government of Canada to take some provisions for the defense of Vancouver before the departure of said Engineers by having the necessary surveys and plans of fortifications made by them before leaving the Pacific Coast.

That this resolution be forwarded to the governor in Council through the Honourable Minister of Militia and Defense for Canada and that said Minister be requested to urge the necessity and importance upon the cabinet and make all necessary representations to the Imperial Authorities to secure the object mentioned in this Memorial. Carried.

Alderman Lefevre moved that the Amendments to the Health By-Law be read a second time. Carried.

The rules were suspended and Council went into Committee of the Whole with Alderman Lefevre in the Chair.

By-Law was read clause by clause in Committee, after which it rose reporting By-Law complete with Amendments.

Moved by Alderman Lefevre seconded by Alderman Alexander. That the By-Law be renumbered 61, read a third time and signed sealed, engrossed and printed. Carried.
