Vancouver April 23rd 1889

The Council met on Tuesday April 23rd 1889 at 7:30 P.M.

Present His Worship, Mayor Oppenheimer, Aldermen Brighthouse, Brewer, Costello, Clark, Mason, McConnell, Oppenheimer, Salsbury and Whetham.

The Minutes of last meeting were read and adopted.

Communications

From Francis Crosbie asking to be allowed remuneration for filling in lane in Block 13, 541 and on Georgia Street. Filed.

From M. W. Thain, Harbour Master giving permission to the Council to dump in the old place for one month longer. Referred to Health Inspector.

From Yates & Jay, Barristers asking compensation for Andrew Smith for injuries received from falling off the sidewalk. Referred to Finance and City Solicitor.

From Alfred Bunker offering to put in Box Drains on Drake St. etc. Referred to the Board of Works.

The Board of Works met on Thursday April 18th 1889.
Present Aldermen Brighthouse, Horne, Oppenheimer and McConnell.

We beg to recommend:

1. That the City Clerk be instructed to advertise for applications for the position of Pound Keeper, such Pound Keeper to be paid out of the fees collected under the By-Law.
2. That the pound be fenced in with a close board fence, 6 feet high with a lattice work gate, 4 feet wide furnished with proper hinges and locks estimated cost \$68.00.
3. That the North fence of the cemetery

be moved south and put on the new line run by the Provincial Land Surveyor.

4. That James Ironsides' tender for sidewalking Carl Avenue be accepted.

2. That the President of the Vancouver Rifle Association be communicated with informing him that the Council cannot see its way clear to grant any funds in aid of his Association at present.

3. That A. S. & G. Hammersly be tendered \$50.00 for services to be rendered in connection with the consolidation of the City Charter and amendments to the By-Law.

4. That 68.00 be granted to the Board of Works for the construction of a Board Fence around the City Pound Site.

Moved by Alderman McConnell seconded by Alderman Oppenheimer. That the Contractor excavating on Hastings Street be allowed 15 cts per yard for fillings in the lane only under the supervision of the City Engineer. Carried.

By-Laws

Moved by Alderman Brighthouse seconded by Alderman Brewer. That the By-Law to regulate drays etc. be read a second time. Carried.

The Council then went into Committee of the Whole on the By-Law with Alderman Oppenheimer in the Chair.

Thirty three clauses were read after which the Committee rose to report progress and asked leave to sit again.

Notice of Motion

Alderman Brewer gave notice that at the next meeting of Council he would bring in a motion for this Corporation to purchase the City Wharf from the present Wharfage Co according to the privilege in the Agreement with said Co and By-Law No 15 of this City.

The Council then adjourned.
