Vancouver May 31st 1901.

The Council held a meeting on Friday May 31st 1901 at 5 P.M.

Present His Worship the Mayor and full Board of Aldermen.

The object of the meeting was to consider several money By-Laws.

It was moved by Alderman ~~N~~ Foreman

Seconded by Alderman McGuigan

That the Council go into Committee of the Whole to consider the By-Law to borrow \$60000 for the extension of the Water Works System.

Carried.

Alderman Foreman was appointed Chairman.

After the title was read the Committee rose and reported progress and asked leave to Sit again.

The Council then adjourned.
